

# **RAC SADDLE CLUB LIVERY AGREEMENT**

This document is a Livery Agreement between the RAC Saddle Club (hereinafter referred to as "THE CLUB") and Mr \ Mrs \ Miss (hereinafter referred to as "THE LIVERY").

The type of agreement is for: **FULL LIVERY**

## **Conditions of Acceptance**

THE LIVERY is responsible for furnishing THE CLUB with a current address and contact number, without which, no agreement can be entered into.

THE CLUB agrees to provide the following services as full livery, on receipt of this agreement signed by both parties and with payment in advance for one calendar month. No agreement can be entered into without these conditions being met and no equines will be accepted until these conditions are met.

## **FULL LIVERY SERVICES**

- I. Provision of sound and dry stabling (bedding to be supplied by the Club and charged retrospectively).
- II. To feed, water and muck out daily, according to the needs of the equine, (feed to be supplied by the Club and charged retrospectively).
- III. To bring in and turn out the equine as appropriate and in accordance with Yard routines.
- IV. To render minor equine first aid and to notify THE LIVERY of any major injury as soon as possible. In the event of being unable to contact THE LIVERY, a veterinarian will be called to administer any major treatment required.
- V. To groom the equine daily and to pick out the hooves.
- VI. Ensure that any medication prescribed (or feed supplements supplied) are given to the equine as per instructions.
- VII. Ensure hay nets are kept full when equine is in (hay to be supplied by the Club and charged retrospectively)

## **Additional Services (Rechargeable)**

- a) Clipping, charges as displayed in the Yard Office
- b) Pulling and Plaiting, charges as displayed in the Yard Office
- c) Shoeing, cost of Farriery plus 10%
- d) Schooling, charges as displayed in the Yard Office
- e) Lessons, charges as displayed in the Yard Office
- f) Veterinary supplies will be charged at cost plus 10%, unless The Livery provides their own
- g) Horse Walker, charges as displayed in the Yard Office, and with prior arrangement with Head Girl

## **Payment Terms**

Bills will be sent out and payment should be made by the 15<sup>th</sup> of the month of receipt. Livery charges are monthly in advance, all additional charges are charged retrospectively. (See above). THE LIVERY will incur a surcharge of 10% on any outstanding balances brought forward and persistent late payment will result in the termination of this agreement, and if necessary the sale of the equine to recover any moneys due.

## **General Terms**

THE CLUB will endeavour to provide tack boxes for THE LIVERY, however they may because of the constraints of space be unable to do so. THE LIVERY remains responsible for the security of their own tack at all times.

THE CLUB will endeavour to provide the best possible security of the stables and paddocks.

THE LIVERY must observe the Health & Safety Policy of THE CLUB at all times, serious breaches may lead to THE LIVERY being asked to leave THE CLUB premises. Policy displayed in the Office.

THE LIVERY must provide evidence of valid inoculation against equine 'flu & Tetanus and 3<sup>rd</sup> Party Insurance cover, plus provide assurance that the equines worming programme is up to date, without these the equine will not be accepted on the yard. Upon arrival at the yard the horse may be subject to a period of quarantine.

THE LIVERY may use such schools and facilities as are available at the stables, subject to them not being in use by the Yard and on the understanding that they do so at their own risk.

Termination of this agreement by either party will be in writing, giving one months notice.
